## SCTPA Memberships for 2003/04

Please remember that you will need to renew your SCTPA Membership. The rates have remained the same as last year. Memberships are due at the first winter penning and will be for the 2003 Winter and 2004 Summer Series.

The **SCTPA** membership fees are:

\$25 Individual

\$40 Family (*to qualify children must be under 18 years of age or still attending school while living at home*)

\$10 Youth (*17 years or younger - if they are not qualifying as part of a family*)

**IMPORTANT:** ALL Members must sign a waiver form and pay an Insurance Fee **BEFORE** they will be allowed to ride at any SCTPA sanctioned event.

The insurance fee is \$10.00 per person and will be collected at the first penning you attend. It will be for the 2003 Winter and 2004 Summer Series.
